Strategic Plan Implementation

- Goal 1: Increase community resiliency
- Goal 2: Expand whole-of-community all-hazards response and recovery capabilities
- Goal 3: Strengthen agency all-hazards mission capabilities





Capability Building Grants

- **Eligibility:**

- NC Counties with a population of 210,000
- Round 1 – \$2 Million Available
- Round 2 – \$3 Million Available
 - NOFO available online
 - Application deadline of March 31, 2023
 - Counties can submit up to 2 projects
 - \$500,000 cap per sub-applicant

- **Program Priorities:**

- Increasing local mass care and human services capacity
- Preparedness initiatives
- Improving incident management/coordination capacity
- Improving EOC capabilities, to include technology initiatives for continuity of operations purposes
- Resiliency initiatives
- Other items supported by a documented local or regional risk assessment/THIRA





State and Local Cyber Security Grant Program

- \$5.3 million awarded to North Carolina
- State adding 10% non-federal cost share increasing grant program to 6 million
- 80% is required to passthrough to local
- 25% required rural passthrough
- Local government entities, community colleges, tribal governments, and state agencies in North Carolina are eligible to apply for FY22 SLCGP funding.
- Application and information online
- April 30, 2023 at 5pm application deadline





Non-Profit Security Grants

- FEMA / DHS Funding for eligible 501(c)3 non-profit organizations
- Terrorism / extremist focused
- Informational Webinar held March 20, 2023
- Deadline for applications is 5pm on April 14, 2023





Partnership Engagement Section

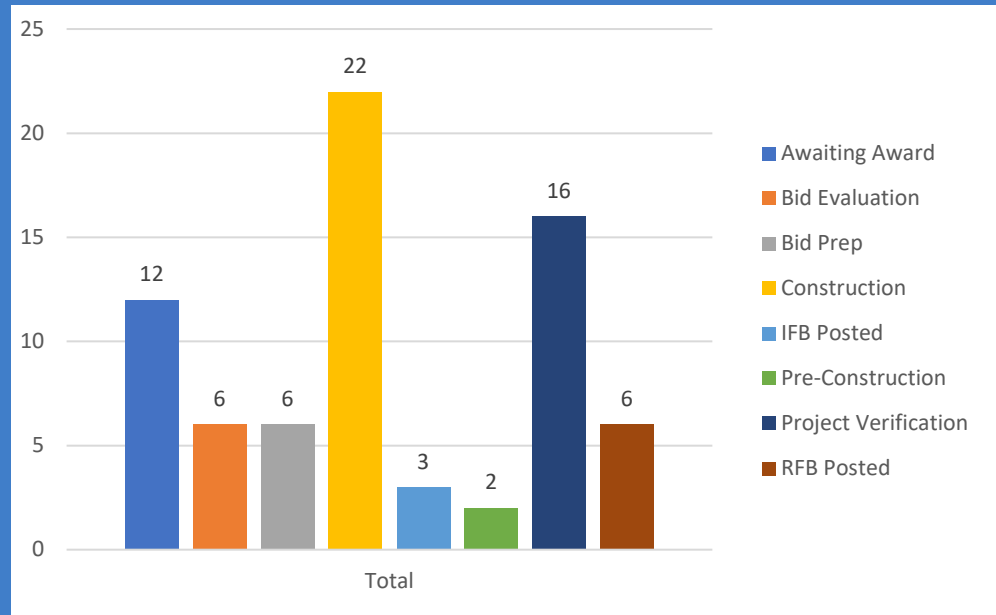
- Hiring the Assistant Director Position for Partnership Engagement

Mitigation Program Progress

- Implementing online management system based in Salesforce to support seamless program management
- Significant progress on state centric project management
- Received extension for Hurricane Florence HMGP grants
- Discussing with FEMA ability to extend State Centric to additional storms
- Received highest number of BRIC awards in the country

- NCEM's legislative agenda:
 - Reduce reliance on EMPG and HSGP grant programs
 - Additional support for school safety
 - Extensions of grants (CBCG, Mitigation, Transportation)
 - Shelter infrastructure grant
 - Technical corrections and updates to NCGS 166a

Shelter Framework Update

- Finalizing the shelter host MOA agreement based on feedback received in listening sessions
 - All-hazards focused
 - State financial support
 - Removing barriers to implementation
- Working through a coordination concept of operations focused on
 - Locally managed
 - Regional coordinated
 - State supported





Hurricane Concept of Operations

- CRES-SOG elements being consolidated into a new document
- Highlights elements already documented and in place from State Emergency Operations Plan
- Recognizing unique elements of a coastal hurricane incident, but focusing on timing to be utilized for event regardless of impact location
- Coordination and collaboration during the incident will remain key
- Next Steps – Document sent for review this spring





Emergency Management Performance Grant

- Held nine small group, regionally based listening sessions during January 2023
- Discussed need for program adjustments for closer alignment with grant guidance
- Discussed importance of allowing local flexibility to address needs of the community
- Collating themes from the listening sessions into a single document for stakeholder review
- Document review planned for Spring 2023
